- * Code EVOL (Evolution) means that the ordered part can be replaced. If delivered part is different than ordered part, it can be installed. Parts are selected based on inventory available.
- Code EVOQ (Qualified Evolution) means that the ordered part is replaced by one or more parts predicated on technical review.
- * Code EVOM (Multiple Evolution) means that the ordered part is replaced by a list of parts with out aircraft or version restriction.
- * Code EVOD (Differentiated Evolution) means that the ordered part is replaced by one or more parts depending on aircraft effectivity.
- Code VANM (No Mixable Variant) means that the ordered part is replaced not by onc, but by set - same use effectivity.
